

Family Survey for MRSD Fall 2020 Re-Opening

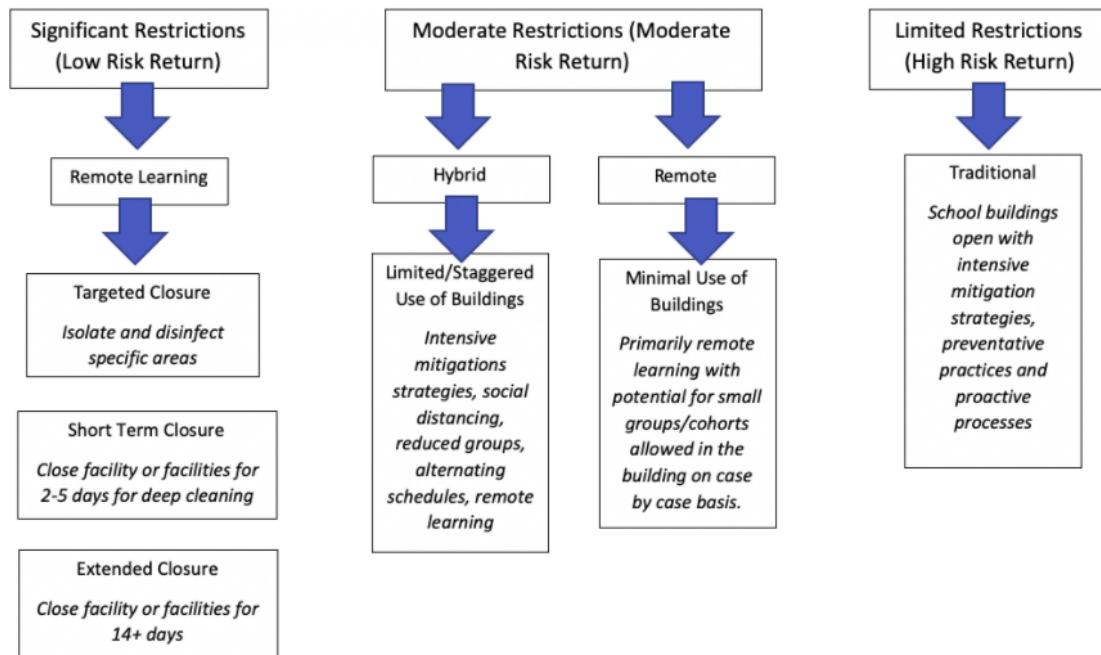
